Admissions Seekers under **Tuition Fee Waiver Quota** in **B.E./B.Tech. / B.Pharma/ BHM&CT** course in the State of Haryana for the Session 2010-11.

Tuition Fee Waiver candidates

As per AICTE, 10 percent of sanctioned intake per course are reserved for Tuition Fee Waiver candidates. These seats are supernumerary in nature i.e. over and above the sanctioned intake.

Criteria:

- i. Sons and daughters of parent having annual income of less than Rs. 2.50 lakhs from all sources shall only be eligible for seats under this scheme.
- ii. Admission under AICTE Scheme of Tuition Fee Waiver is meant for eligible women, economically backward and physically handicapped students.
- iii. **Only Haryana Resident** candidates may apply for these seats.

The photocopy of the proof of same is also to be attached. **Candidates who have already paid counseling fee of Rs 500/- (non-refundable) through www.hscs.org need not deposit it again. They will have to send the filled in application form alongwith all relevant documents to HSCS office and also attach the copy of proof of fee deposition.**

These candidates shall fill up the Application Form available on the website www.techeduhry.nic.in & www.hscs.org and submit the Application Form along with attested copy of *relevant category certificate i.e. 10+2 School certificate for women category, Handicap Disability Certificate from Civil Surgeon heading the constituted medical board as given at Annexure –XI of respective admission brochures(The handicap disability should not be less than 40 % and should not interfere with the requirement of the professional career as an Engineer/Architect/Technician in all the courses) in case of PH candidates and Parents Income Certificate from all sources from the organization where he and she is working or Affidavit of Income on stamp paper from Notary (Annual income of Parents/Guardians should be less than Rs. 2.50 lakhs from all sources), in case of all eligible TFW candidates*, at HSCS office **till 20.8.10 upto 5.00 PM**.
